Schedule: All classes meet for 37 weeks during the 2008/2009 School year. Our schedule parallels the University calendar and we observe the same vacations.

#Tuition: Tuition prices are subject to change. There is a \$75 non-refundable annual registration fee due after child's acceptance. **The last month's tuition (May, 2009) is due no later than June 6th, 2008 and is not refundable after August 1, 2008.**

How to apply: Parent(s) interested in the program should observe a class in progress. Classes are held on the first floor of the AEB in rooms 136 & 156. Labeled observation rooms surround both classrooms. Complete the application and return it by *****February 15TH, 2008*****, to: Dept. of Family & Consumer Studies, 225 S 1400 E, 228 AEB, Salt Lake City, UT 84112. This information is confidential and will be used for research only. Applications received after this date are put on a waiting list.

Selection Process: Children will be randomly selected from specific research criteria (age, gender, etc.). Parents will be notified by mail if their child has been accepted in the program. Notification will be mailed by March 15th, 2007. Within two weeks after notification, a registration fee of \$75 is required to reserve your child's place in the program.
